



# Benninghoven Dodgeball Tournament

Admission:	\$2.00 for adults / \$1.00 for kids CASH ONLY (exact change preferred) No admission for registered players, coaches, and managers.

All are welcome to come and watch the fun!

**This is not a drop-off event.** Students should not be dropped off without adult supervision!

- Tournament is open to all current Benninghoven students. Teams may be any mix of genders/ ages/grades.
- Entry fee: \$100 per team of eight (8) players. All players start on the court (no substitutions).
- Each team must have a designated team coach.
- A "ringer" may be purchased for the team for an additional \$30. Ringers are optional. (More info below.)
- The Team Spirit Award will again be given to a team demonstrating outstanding sportsmanship and team pride!
- Concessions will be available for purchase.
- Registration is limited to the first 16 teams to turn in a completed registration packet and entry fee (see following page) to the school office.
- Deadline for entry is **February 9th, 2023** (or until tournament is filled with 16 teams).

## TEAM REGISTRATION INFORMATION

- Teams may pay an additional \$30 to add a ringer to their team as an extra (9th) member. Teams must recruit their own ringer. Ringers may be friends, siblings, parents, relatives, community members, teachers, staff members, etc. Ringers must sign a waiver and abide by the same rules as players and coaches.
- There are no specific game times posted prior to the tournament. Teams are encouraged to be present at 1:00 pm and stay for the entire event (or until they are eliminated). The tournament will conclude no later than 5 pm.
- Teams must be present in the pre-game area prior to their game. Failure to be present in the pregame area can result in a forfeit.
- There will be a **mandatory coaches meeting on the evening of February 15 from 7-8 PM in the MPR** to distribute and discuss tournament rules and answer questions. If the coach is unable to attend, a parent from the team must attend in their place. The coach or parent attending the meeting is responsible for disseminating pertinent information to the team.
- Most teams elect to do some type of "uniform" or team shirts. This is not required but may be organized by the team if desired.

### **REGISTRATION PACKET:**

**Incomplete Registration Packets will be returned and will not hold your spot. Please make sure you have included all of the following items to ensure your team's spot in the tournament:**

1. Completed Registration Form (below) listing ALL players and current grade level as well as team manager and coach's names and contact information. The same person may serve as the team manager and coach.
2. One check made payable to Benninghoven PTA for entire amount including team entry fee and ringer fee (if applicable).
3. Signed Release of Liability Form (below) for each player, coach, and ringer (if applicable).

**BENNINGHOVEN PTA DODGEBALL TOURNAMENT  
AGREEMENT FOR ACCEPTANCE OF RISK AND RELEASE FROM LIABILITY**

This Agreement is to be signed by an adult for himself/herself or for his/her children that will be participating in the Benninghoven PTA Dodgeball Tournament.

I agree for myself and/or for my children named above to the following:

1. I understand that some of the activities in which we participate at the Benninghoven PTA Dodgeball tournament may result in injury. Injuries can result from falls or bumps; misuse or damage to equipment; carelessness, recklessness or negligence by ourselves or other patrons; the physical and/or emotional exertion of the activity itself; being in poor health or poor physical condition or other causes. These activities have the inherent risk of injury, including possibly very serious or life-threatening injury, and by participating, we accept full responsibility for these risks.
2. It is my responsibility to supervise myself and the children in attendance with me; to keep track of all children in attendance with me and know where they are at all times. To take care to avoid the causes of injury described above; to make sure that none of us engages in any activity for which we are not physically, mentally and medically fit; to stop any activity at the first sign of unacceptable risk, danger or possible injury; and to seek immediate medical care in the event of an injury. I understand that neither volunteers of the Benninghoven PTA Dodgeball tournament nor the staff of Benninghoven will be responsible for this supervision.
3. I waive and release all claims, demands, causes of action, liabilities and costs which might otherwise be asserted, and covenant that no claim or lawsuit will be brought against the Benninghoven PTA or any of its members or volunteers for injuries of any nature to me or any of the children in attendance with me as a result of or in connection with our attendance or participation in activities at the Benninghoven PTA Dodgeball Tournament.
4. I, and the children in attendance with me, will abide by all rules and regulations of the Benninghoven PTA Dodgeball Tournament and may be removed from the premises without any refund if we fail to abide by the terms of this Agreement.
5. I represent that I have the authority to sign this Agreement for myself and for each of the children named above. I will indemnify the Benninghoven PTA against any attorney fees, costs or other losses it incurs if a claim is brought in violation of this agreement.
6. I SIGN THIS AGREEMENT VOLUNTARILY, WITH THE UNDERSTANDING THAT BY DOING SO MAY BE GIVING UP SUBSTANTIAL LEGAL RIGHTS.
